Sanction of the President is hereby conveyed for continuation of the Establishment of "Sardar Swaran Singh National Institute of Renewable Energy"(SSS-NIRE) of the Ministry of New & Renewable Energy during 2007-08.

2. The programme activities for the establishment of SSS-NIRE will be implemented during 2007-08 as per the same norms/ guidelines and other provisions applicable during 2006-07 as announced vide continuation sanction order issued by the P&C Division of the Ministry vide Order No. 1/1/2005-P&C dated 26-05-2006 and until such time the same is superseded by fresh schemes which are required to be formulated in alignment with the 11<sup>th</sup> Plan proposals.

3. Release of Grant-in-aid/ Central Financial Assistance (CFA) sanctioned during 2007-08 on the basis of provisions of programmes/schemes of 2006-07 will continue to be governed by the said provisions even after the same are superseded by fresh / new programme/ schemes. Some of these schemes are likely to be replaced by new programme/ schemes during the course of the year to be implemented during the 11<sup>th</sup> Plan period. As and when such new schemes are approved and conveyed, the old schemes would be replaced and the new norms would apply. Till such time, the old existing schemes would continue to be implemented.

4. All concerned agencies and organizations are requested to take up activities for the establishment of SSS-NIRE for implementation as per the guidelines of 2006-07 till further communication.
